2 Minutes of the Last AGM and matters arising

The AGM passed the motion that the minutes of the last AGM in Toledo be accepted as a true and faithful account on the proceedings.

3 President's Address

The President stressed that the points mentioned (see appendix 1: President's Address AGM 2002) are not only related to activities of herself but key issues we focussed on in 2001 and where we did and did not succeed.

She highlighted some activities related to the communication policy.

The structure of the website is updated to make it easier to maintain, the new website will be launched this summer.

A Nordic DfA Magazine will be published by NSH, with EIDD represented in the editing board.

There is an increasing number of workshops, seminars and conferences related to DfA in which EIDD participates.

The relationships EIDD and design organisations (ICSID, IFI) have been activated.

The development of the DfA Award scheme is processing; very recently the President and Honorary Secretary had a positive meeting with EC DG Employment on cooperation.

We did not succeed to produce the e-newsletter and activate EIDD members in communication. We, the executive, are aware we have to improve the necessary communication from executive to board.

The Membership activities show a slow process, we still miss NMO's.

We proceeded with a number of things concerning the EIDD organisation, we are getting there.

Although we do not have a good strategy yet to find external funding at least we have one success: the IDIA project funding (with special thanks to Pete kercher who is managing the project).

EIDD will possibly be subcontractor in the IDC.net project.

Discussion:

Paul Hogan congratulated on the President's report. He was positive on all the work done, especially the relation with EU and design organisations, we should be the expert advisers there.

His only critical point was on the communications. Paul wondered why not writing a president's letter now and then as he suggested in the Rotterdam Board Meeting. He already indicated in this meeting that the e-newsletter was just to ambitious.

The president replied that the lesson has been learned, but the main executive's task is to find the trigger to activate <u>all</u> Board Members in communication. Jim Sandhu liked to endorse what Paul has said. We have to come out the grey shades by a message or newsletter. We still need to exploit that to enhance our mission: money (that makes thing happen). The Newsletter doesn't have to be that long, just a monthly or bimonthly message what is happening.

Päivi agreed that what Jim Sandhu said was very relevant. She stressed that we really need to strengthen the front, and need to use also other possibilities other than a newsletter.

Finn Petren also congratulated with the report.

4 Honorary Secretary's report

The Honorary Secretary presented shortly the activities 2001 (see appendix 2: EIDD Activity Report 2001).

Most striking in the activities was the increasing international activities combined with ongoing increasing national activities.

Jim Sandhu shared his concern that EDF information is getting bulkier and because of that it is difficult to resume all information before sending it to the Board. He wanted some feed back how to proceed. Karin Bendixen suggested to put all material on a closed section on the website. Päivi Tahkokallio thought this was for the time being a good suggestion.

Francesc Aragall added to the activity report his participation in the ECA (European Concept of Accessibility) network.

5 Honorary Treasurer's report

The Honorary Treasurer explained the accounts (see appendix 3: Financial Statements 2001 & Income and Expenditure Account 2002) were not audited because there was a lack of money to pay an auditor.

He concluded we spend in 2001 more money than we received. Luckily we recently received the money from the IDIA project.

Paul Hogan asked if the IDIA money has to be spend on the project, or is there a surplus to spend as EIDD. Päivi Tahkokallio explained that 20% of the total budget is overhead we can use for EIDD; funding for travels can be used for travelling costs AGM 2003 since the AGM is combined with an IDIA workshop in Dublin. Of course EIDD is responsible for production of content for this workshop and the project.

The meeting approved the treasurers report.

6 Membership

The Membership Secretary presented the latest update of the membership directory, proposals for admission of two new members and a proposal for new annual membership subscriptions (see appendix 4).

Eidd Belgium is proposed to be admitted as a National Member Organisation, Danish Centre for Technical Aids for Rehabilitation and Education is proposed to be admitted as a Corporate Member Organisation.

The meeting accepted both Member Organisations.

Paul Hogan suggested that the 7 NMO's is not good enough. He wondered what action has been, and will be, taken to increase the NMO's.

Lilian Henze apologised for the slow progress, her only excuse is that combining the tasks of the Honorary Secretary and Membership Secretary is just too much to do it as good as she had in mind. Francesc Aragall reminded that 2 years ago we only had 2 members, so we already made an improvement. He also indicated the importance that all board members take their responsibility.

Finn Petren stressed the fact that there is a membership secretary to work on that and for the future of EIDD we really need the NMO's.

Erik Peuschel introduced 3L/DEFA, trying to organise the German network. One of their main projects is the City for All (a 4,5 year project).

Hubert Froyen asked Erik if there will be any connection with things Dieter Philippen already has done. Frances Aragall suggested to hand over all relevant information to DEFA concerning past activities in Germany.

Paul Hogan welcomed Erik and hoped he will take the challenge to build a good National German network.

Päivi Tahkokallio hoped to move things ahead in Austria from the conference in Grazz she will attend. In the IDIA project is a French partner (VIA) that is interested to develop a French network. In Finland the DfA Centres of Excellence network will be developed..

Pete Kercher added that in the IDIA project also Greece and Poland are partners. He suggested to use these contacts to build national networks. Jim Sandhu reminded that Greece is in a difficult position because there is a sort of block we had to deal with in earlier attempts.

Karin Bendixen indicated that a Danish Design for All network is in progress, she had her hopes to become a NMO soon.

Frances Aragall suggested to establish a Benelux network.

The proposal to increase the annual subscription with 100% was received positively but could not be accepted by the NMO's representatives because they didn't have a mandate.

Pete Kercher proposed the assembly to mandate the board meeting to decide in the Autumn. The meeting agreed with this proposal.

7 National Reports

Päivi Tahkokallio invited the meeting to add anything to the National Reports.

Francesc Aragall added that the Spanish NMO will be located at CRID. At this moment they trying to be the umbrella for the Centres of Excellence. Karin Bendixen added that the Danish Centre also is involved in the DfA COE.

Jim Sandhu wanted to stress that there is a lot of duplicating of activities. In his work for CEN (with John Gill), on the CEN/CENELEC ICT guidelines, there is also a direct relation to education. 'We need to progress instead of duplicate'.

Päivi Tahkokallio suggested to take a step further and not have this only yearly report but report national activities throughout the year.

For the AGM 2004 Päivi Tahkokallio suggested Athens.

Also Stockholm is proposed by Lennart Lindkvist.

Also possibilities to connect the coming AGM's to the DfA Award is proposed.

10 Any Other Business

Jim Sandhu asked all Board Members to give positive response to India.

11 Closure

The President thanked Hubert Froyen and EIDD Belgium for their warm hospitality and splendid organisation of the Education Conference and EIDD workshop and meetings facilities.

The assembly was closed at 10.40 hrs.

In December 2001 the Dutch design consultancy GRiPP is asked to make an offer for redesign (to make the website easier to maintain).
