3. Agenda

The agenda was approved as proposed.

4. Minutes of the 3rd GA in Avila

There were no matters arising from the minutes of the 3rd General Assembly, held in Avila on 28-29 June 2013. Markus Haas proposed approval of the minutes and Pepetto Di Bucchianico seconded. They were accepted as a true and faithful record of the proceedings.

5. President's Address and Board Report

The President, Ewa Golebiowska, presented the Board Report, which ended with a round of applause.

Jan Stavik proposed approval of the Board Report and Nuno Sa Leal seconded. They were accepted unanimously into the minutes by the assembled members.

6. Annual Financial Report

6.1 The Financial Report for 2013 was presented by the Vice-President Finances, Markus Haas.

Discussion ensued about fees overdue from some members and the fact that some of these members are "silent members". A consensus was reached that the Board should communicate with these members, so as to determine their intention to pay and play and active part in the life of the association.

Jan Stavik proposed to authorise the Board to decide to allow a leeway of, for example, two years, after which membership shall lapse: lapsed members can always reapply for membership in future. After discussion of this proposal, the GA **decided** to allow for a "gentlemen's agreement" of 13 months.

The approval of the 2013 Financial Report was moved by Veronika Egger and seconded by Karin Bendixen, then approved by the GA.

6.2 Budgets for 2014-2015

The Budgets for the years 2014 and 2015 as proposed by the Financial Vice-President Markus Haas were approved unanimously. The GA moved a vote of thanks to Markus Haas.

7. Membership issues

7.1 Retirement of members

The following members have informed the Board that they have ceased to exist or wish to retire from membership:

- 7.1.1 The Creativity Zentrum, Bilbao, Spain, ceased to exist on 31 December 2013.
- 7.1.2 The Design Information Centre, Riga, Latvia, has expressed its intention to withdraw from the association.
- 7.1.3 The Moholy-Nagy University, Budapest, Hungary, has expressed its intention to withdraw from the association.

The General Assembly took note of these changes and ratified them

7.2 Ratification of new members

The GA was requested to ratify one membership granted by the Executive Board since the previous GA and to deliberate about one further new application presented at the GA.

7.2.1 Gdynia Design Centre

Ewa Janczukowicz-Cichosz and Malwina Studzinska made a short presentation of the work of the Gdynia Design Centre, whose membership had been approved by the Executive Board and was now ratified.

7.2.2 Department of Science of Architecture, University of Genoa Silvia Perico presented the work of the Department of Science of Architecture and specified that its application for membership was supported by both Design for All Italia and the DdA at the University of Chieti-Pescara, the two existing members from Italy, which both confirmed their support.

The GA then approved the application for membership.

8. Membership survey and future priorities

Terhi Tamminen presented the member survey conducted in the course of the previous year, followed by a summary of its results.

Peter Neumann then presented the strategy and roadmap for 2014-2020, based on the results of the survey.

These presentations were followed by a long discussion, focusing especially on the emphasis attributed the two main approaches to the association as a network and/or as an organisation.

This discussion eventually led to a consensus that the main focus at present is on the need for networking, although this does not preclude the need to remember a secondary focus also on the organisation.

For this to be effective, a two-way flow of information is vital.

9. New website

Pepetto Di Bucchianico presented the new EIDD – Design for All Europe website (www.dfaeurope.eu), which has been designed for use on computers, tablets and smartphones and to allow collaborative working.

The GA then discussed the new website and made suggestions for the best models of site accessibility, advice about matrices etc.

The GA applauded Pepetto Di Bucchianico and approved a vote of thanks to him for his work.

Past President Finn Petrén promised to provide access to the old website (www.designforalleurope.org) so that the technicians working with Pepetto Di Bucchianico can import all relevant material and then close the old site down.

The GA adjourned at 19.00 and reconvened the next morning at 9.00.

10. Working Groups

The GA spent the morning of 28 May working in two groups:

- 1. Academic research and programmes in Design for All
- 2. Design for All in public spaces and services
